No more than two applications of any QoI fungicide may be made to crops of barley, oats, rye or triticale.

After spraying, wash out sprayer thoroughly according to manufacturer's guideline and dispose of washings and clean containers according to local authority guidelines.

Resistance Management

BALAYA should be used in accordance with the instructions for use for the target diseases at the specific growth stages indicated.

Use BALAYA as part of an Integrated Crop Management (ICM) strategy incorporating other methods of control, including where appropriate other fungicides with a different mode of action.

BALAYA should be used preventatively and should not be relied upon for its curative potential.

You must not apply more than two foliar applications of QoI containing products to any cereal crop.

There is a significant risk of widespread resistance occurring in *Ramularia collo-cyni* populations to a number of different modes of action. Repeated use of products containing the same mode of action are unlikely to provide effective control of this disease. For further information on the resistance status of *Ramularia* contact your agronomist or specialist advisor and visit the FRAG-UK website the best way of managing this disease.

BALAYA contains mefentrifluconazole, a DMI fungicide. Resistance to some DMI fungicides has been identified in Septoria leaf blotch (*Mycosphaerella graminicola*) which may seriously affect the performance of some products. For further advice on resistance management in DMIs contact your agronomist or specialist advisor and visit the FRAG-UK website.

There is a significant risk of widespread resistance occurring in *Septoria tritici* populations in Ireland. Failure to follow resistance management action may result in reduced levels of disease control.

To minimise the risk of resistance developing against *Septoria tritici*, BALAYA should be used in mixture with products from a different fungicide group to the triazoles or QoI at a dose that will give a robust control.

Crop Specific Information

Crops

BALAYA is a systemic fungicide with protectant properties for disease control in winter barley, spring barley, rye, triticale and oats.

Time of Application

For best results apply BALAYA as a protectant treatment or at first sign of foliar disease attack. A maximum of two applications can be made up to and including flowering anthesis just complete GS 69) in barley, rye, triticale and oats.

Rate of Application

Apply 1.5 litres BALAYA in a minimum of 100 litres of water per hectare.

Mixing and Application

Apply as a MEDIUM spray, as defined by BCPC.

Half fill the spray tank with clean water and start the agitation. SHAKE THE CONTAINER WELL before use and pour in the required amount of product. Rinse any empty containers thoroughly and add rinsings to the spray tank. Add the remainder of the water and continue agitation until spraying is completed.

When tank mixes are to be used, each product should be added separately to the spray tank, taking due note of any instructions given as to the order of mixing.

All tank mixes should be used immediately after mixing.

EASY CONNECT



The easyconnect system requires a coupler for its use.

Step by step instruction for use with coupler:

- **Do NOT unscrew the easyconnect cap**
- Remove the dust cover
- **Do NOT push the plug manually into the container!**
- Turn the container upside down to connect the easyconnect cap to the coupler, then follow the instructions from your coupler supplier.
- After complete emptying and rinsing, push the plug into the container using a spike on the draining rack, allowing any residual rinsing water to drain.
- The easyconnect cap can be recycled together with the container according to local regulations. Do not transfer cap onto any other containers.
- **Note:** Whilst using the easyconnect coupler, please continue to wear PPE in line with the guidance on the product label.
