### Application:

Green Lawnger® PRO HC is tank mixable with most professional plant protection products, liquid fertilisers and biostimulants commonly used in turf management (for full tank mix compatibility details please contact your local supplier).

Note: Allow sufficient drying time for the product to fully adhere to the plant before allowing access.

### ALWAYS FOLLOW PESTICIDE MANUFACTURER'S LABEL DIRECTIONS

- Fill the sprayer tank 1/2 to 2/3 the total volume of water and begin agitation.
- Green Lawnger® PRO HC colorant should be added to the mix solution.
- Allow Green Lawnger® PRO HC colourant to fully disperse into mix solution before adding additional products.
- Fill remainder of the sprayer tank with water to the desired volume.
- Always apply any pesticide solution mix to the target site at the rate specified on the pesticide manufacturer's label.

For best results, use low to medium sprayer pressure. Avoid overspray on any area where colour is not desired, otherwise permanent staining may occur. Accidental overspray may be removed by a water rinse prior to drying.

### Equipment Cleaning:

After application, always drain and clean the sprayer tank, pump, hoses, valves and nozzles as instructed by the pesticide manufacturer's label.

- After initial rinsing, the use of a spray tank cleaner will facilitate additional removal of pesticide residue from equipment.
- Do not leave pesticide mix solutions with Green Lawnger® PRO HC colourant in the sprayer tank overnight.

### CAUTION:

Keep out of reach of children. If inhaled, move to fresh air and seek medical attention. In case of eye contact, flush with running water for 15 minutes and seek medical attention. On skin contact, wash thoroughly with soap and water. In case of ingestion, rinse mouth and drink plenty of water. Do not re-use this container. Rinse contents into the spray tank and crush prior to disposal. Waste must be disposed of or incinerated in accordance with local regulations. Safety data sheet available on request.
